Long Form Snuggle Bugz Contest Rules, Terms, and Conditions

Eligibility

The contest is open to all legal residents of Canada who have reached the age of majority in their Province of residence, except residents of Quebec, employees of Snuggle Bugz and its affiliates, franchisees, agents, associates, dealers, representatives, advertising and promotional agencies and members of their immediate family.

Skill testing questions required to claim prize.

How to Enter the Contest

a) There is no purchase necessary to enter the Contest. Enter using 1 (one) of the 2 (two) entry methods outlined below.

 - i. Entrant must complete Rafflecopter submission on blog post web page with full name, email address, and response to required question.
2. Social Media Entry:
 - i. Entrant must be following @snugglebugzbaby on Instagram
 - ii. Entrant must “like” contest image
 - iii. Entrant must complete Rafflecopter submission on blog post web page with full name, email address, and response to required question.

b) By participating in this Contest, entrant acknowledges, represents and warrants that: (i) the Entry does not contain any material that is libelous, defamatory, profane or obscene and does not violate any laws relating to hate speech or otherwise; (ii) the Entry is an original Entry, and that no third party participated as an author, co-author, photographer or otherwise in the creation of the Entry or any part thereof and that all right, title, and interest (including copyright) therein and thereto and is owned and/or controlled by the entrant to the full extent necessary to enable Snuggle Bugz to use the Entry as contemplated by these Contest Rules; (iii) the Entry does not infringe upon the intellectual property or other statutory or common law rights of any third party; and (iv) if

applicable, any minor shown in the Entry and the submission of the Entry is made with the consent of a parent and/or legal guardian of such minor.

c) You agree that Snuggle Bugz may, at any time, edit, modify or remove the Entry, in whole or in part, and may disqualify an entrant from the Contest if Snuggle Bugz believes, in its sole discretion, that the entrant has breached any of the representations and warranties made above including, without limitation, on the basis of concerns relating to the rights of third parties, including but not limited to privacy, copyright, defamation, rights of personality, obscenity or hate speech.

d) All Entries become the sole property of Snuggle Bugz and none will be returned for any reason. By submitting the Entry, the entrant assigns to Snuggle Bugz all of entrant's right, title and interest, including copyright, in and to the Entry, throughout the world in perpetuity. For greater certainty, the entrant acknowledges that, as a result of this assignment, Snuggle Bugz will have the exclusive and perpetual right to exploit the Entry in any media now known or later developed in whatever ways Snuggle Bugz may determine in its sole discretion and to authorize others to do so. This includes, but is not limited to, the right to reproduce, distribute, publish, exploit, display, communicate to the public by telecommunication, transmit, broadcast and otherwise use and exploit the Entry, in whole or in part and to edit, add to, or modify the Entry in any way, all without further obligation or compensation of any kind to the entrant.

e) Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for a Prize.

Right to Cancel the Contest

Snuggle Bugz reserves the right to cancel, terminate, or suspend this Contest, at its sole discretion, in the event of technical failure, computer virus, unauthorized human intervention, fraud or any other occurrence or cause beyond the control of Snuggle Bugz, that corrupts or adversely effects the administration, security, fairness or normal operation of the Contest.

Prizes (a) The prizes are hereafter referred to as "Prize" or "Prizes." Prize winners are hereafter referred to as a "Winner" or "Winners."

(b) The Prize is 1 (one) of 2 (two) Nanit Smart Baby Monitors.

Prize Stipulations

Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of Snuggle Bugz.

Any unused portion of a Prize will be forfeited and have no cash value. Snuggle Bugz reserves the right, in its and its sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason. Prizes are non-transferable.

Prize Distributions

Contest Winner will be notified via email within four (4) to six (6) days of the Contest Period End. Prizes will be forwarded to the winner within four (4) to six (6) weeks after the Winner has been successfully contacted, notified of his/her Prize and fulfilled the requirements set out herein. Snuggle Bugz shall not assume any liability for lost, damaged or misdirected Prizes.

General Rules

Contest Prize winners are subject to verification by Snuggle Bugz and/or its designated representatives.

Prohibitions on Multiple Entries

Contest Participants are only allowed to submit one (1) entry per person.

Contest entries or submissions made with multiple addresses, under multiple identities, or through the use of any device or artifice to enter multiple times or entries that are in excess of the permitted number of entries during the Contest period are automatically void. All Contest entries obtained through unauthorized sources or which are incomplete, illegible, mutilated, altered, reproduced, forged, irregular or fraudulent in any way or otherwise not in compliance with these Rules are automatically void. Contest Participants acknowledge that Snuggle Bugz retains sole and final discretion to validate and/or accept all Contest entries, Contest submissions, Contest Winners, and Prize claims.
